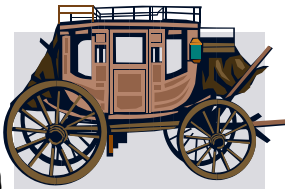

Dispatches From The Territorial Governor

On June 21, 2015, an RO 1 course was conducted in the J.C.S.A. range class room. It was attended by 9 SASS members; four of whom were attending the class for the first time. As a result, we now have four new RO 1's as follows:

Kookanadude (Kira Bell), Newhope Kid (Craig Bain), Twilight Kate (Kaitlyn Schawn), and Cimaron River Deacon (Derrick Schawn). Their RO 1 pins were awarded upon completion of the course. Congratulations to our new RO 1's!

During class discussions, a safety issue arose concerning a shooter at a recent match who temporarily lost control of his rifle when attempting to re-stage it. In this case, the shooter was able to safely catch the rifle before it hit the ground and the muzzle of the firearm never broke the 170 degree rule or swept anyone. While shooters are required to control their firearms at all times, this particular shooter was able to re-establish control without committing any specific SASS rule violation. Therefore, it is a "no call."

If the unloaded rifle had been dropped on the ground, a stage DQ penalty would be assessed. Barring a prop failure, had the unloaded rifle slipped and fallen to the ground after the shooter re-staged it, a minor safety penalty would apply.
